


Coyote Pasture/ South Well Ranch, Hachita, OG.120









Information: This property contains 12,583 acres located in GMU 26 a few miles west of Hachita, NM off Highway 9. The property is a working cattle ranch covered by a mixture of chaparral and native grasses. It has a few wells that supply water for livestock and wildlife. In wetter years, dirt tanks fill and hold water. Water sources provide some pass shooting opportunities for dove. The area can hold good quail populations and be very productive when resources are abundant. Javelina and deer are scattered across the area in low numbers. The property improves access to a considerable amount of neighboring State Trust and BLM lands.

Permitted Activities: Hunting is only permitted on this property during the seasons and dates specified in the Open Gate lease agreement between the Department of Game and Fish and the landowner. Access to the property is subject to the terms and conditions in the Open Gate lease agreement and is restricted to the following permitted activities:

Property Rules: The following rules will be posted on this property and enforced at the discretion of the Department of Game and Fish.

- Use of this Open Gate Property is restricted to properly licensed sportspersons for the following activities: **Dove hunting, quail hunting, deer hunting, and javelina hunting.**
- No trespassing unless you are a properly licensed sportsperson, are accompanied by a properly licensed sportsperson or are license-exempt.
- Each properly licensed sportsperson or license-exempt person is allowed to be accompanied by no more than two guests.
- Scouting is only permitted during the two days immediately preceding the commencement of open season dates.
- No motor vehicle travel off designated roads or on closed roads.
- No destructive acts, including: vandalism, graffiti, theft, removal or defacing natural features, resources or signs.
- No target practice.
- No consumption of alcoholic beverages.
- No camping.
- No fires.
- No littering.
- Access allowed from two hours before sunrise to two hours after sunset.
- New Mexico Statute prohibits discharge of a firearm within 150 yards of a dwelling or building without permission of the structure's owner or lessee.
